

#### **Company Profile**

It is the largest construction contractors in the world, ranking 71<sup>st</sup> in the top 500 companies in the world. CREC was listed respectively on December 3<sup>rd</sup>, 2007 and December 7<sup>th</sup>, 2007 in Shanghai and Hong Kong, with the total assets of RMB 713.67 billion Yuan and net assets of RMB 139.40 billion Yuan.

Constructors of CREC have successively built railways of more than 90000 kilometers, accounting for more than two-thirds of the total length of national railway, accounting for 90% of national electrified railway. #### 公司治理

#### **Company Governance**

In January-June 2015, the Board of Directors was composed of 7 members. From July to December, the former executive director and president Dai Hegen left his post because of job transfer. In January 2016, the company general meeting of stockholders elected a new president Zhang Zongyan as executive director. At present, the Board of Directors is still composed of 7 members including 3 executive directors, 4 independent non-executive directors, and independent directors account for more than half of the Board members. There are 5 special committees of strategy, remuneration and performance assessment, audit and risk management, nomination as well as safety, health and environment committees under the Board of Directors, among which strategy committee is composed of 5 directors and 3 of them are executive directors and 2 of them are non-independent director; audit and risk management committee is composed of 3 directors, all of them are independent non-executive directors who have rich experiences in listed company and large corporate financial management; nomination committee is composed of 5 directors, 2 of them are executive directors and 3 of them are independent non-executive directors; SHE committee is composed of 5 directors, 2 of them are executive directors, and 3 of them are independent non-executive directors. The board of supervisors is composed of 5 members including 2 shareholder representative supervisors and 3 workers' representative supervisors. The upper management is composed of 8 members including 1 executive director and president, 1 vice president and chief engineer, 4 vice presidents, 1 CFO, 1 board secretary and 1 general counsel. In the past year, the Board of Directors insisted on fulfilling responsibilities in system, regulation and procedure in accordance with the law of compliance, fully performed its function of "grasping direction, deciding major issues and controlling risk" to ensure effective connection in decisionmaking procedures of general meeting of stockholders, Board of Directors and its special committee, Board of Supervisors and managers. As a result, governance structure of CREC worked effectively.

In 2015, CREC actively adapted to new normal supervision situation and fulfilled new supervision requirement. In addition, it paid attention to enhancing efficiency promotion under company governance standard. By improving system rules and operation mechanism, studying and perfecting authorization system, enhancing motivation and restriction systems, and on the basis of clear functional orientation of Board of Directors, Board of Supervisors and managers, it constantly improved decisionmaking implementation supervision mechanism in reciprocity of power and responsibility, operation coordination, and effective counterbalance. 

中国中铁高度重视内控体系建设,按照《企业内部控制基本规范》要求,在制定下发《工程项目内部控制指导手册》等相关文件的基础上,2015年,根据企业全面深化改革的需要,加强对内控审计和评价中发现的管理缺陷的整改,修订完善了总部内部控制体系文件。召开管理制度评审会议6次,完成了27项规章制度的评审工作。

公司结合企业实际,在组织开展风险管理初始信息收 集和所属各单位风险评估结果的基础上,编制风险评 估调查问卷,从5大类76个风险点列举出公司层面面 临的风险,从风险发生的可能性和影响程度两个维度 制定风险评估准则,开展了风险问卷调查,评估确定 公司层面重大和重要风险,并编制了《2015年度全面 风险管理报告》。

#### Internal Control Supervision

CREC attached great importance to construction of the internal control system. According to Basic Norms of Corporate Internal Control, by issuing relevant documents including Instruction Manual for Internal Control of Engineering Projects, in 2015, CREC strengthened efforts on defect rectification in internal control under the requirements of overall in-depth corporate reform. With regard to management defects found in internal control audit and appraisal, the company took relevant rectification measures, revised and improved internal control system documents of the headquarter. In the whole year, management system appraisal meeting was held for 6 times, and 27 rules and regulations have been appraised.

In combination with its reality and based on the organization of initial information collection for risk management and risk assessment results of all subordinate units, CREC compiled the risk assessment questionnaire, listed five categories and 76 risk points that it was facing, formulated risk assessment standards from the probability and influence degree of risk, carried out risk questionnaire survey, assessed and determined the great and major risks that it was facing and compiled the Overall Risk Management Report 2015.

#### Improvement of Service Quality

In project quality management, the company seriously implemented ISO9000 system standard, revised Measures for Project Quality Supervision and Management to effectively operate together with the current regulations on project guality control, excellence management, guality accident handling, accident responsibility investigation so as to improve internal quality assurance system for well-organized and controllable management process.

In industrial equipment service, based on major project or product, the company constantly enhanced pre-sale, sale and after-sale services. In addition, it went into the front line and work site to continuously improve its product and service quality and promote its management level.

In financial service, the company established CREC Huida Insurance Brokers Co., Ltd and CREC Financial Holding and Financial Leasing Co., Ltd. In addition, it cooperated with large financial institutions such as banks, insurance companies and trust securities to innovate and develop financial products so as to transform owner-related highguality infrastructure investment into various financial products and introduce them to institutions and individual investors.

Information 1: In 2015, in order to ensure smooth transportation of Hainan Eastern Island-Looping High-Speed Rail during annual conference of Boao Forum for Asia, CREC EEB Operation Maintenance Co., Ltd carried out 37 special rectification tasks to equipment including insulator clearing in heavily polluted area, inspection and rectification of cast light beacon, split-phase magnetic sleeper measurement and tunnel lighting equipment measurement and inspection, etc. During the Forum period, it set up 14 emergency response teams and dispatched 124 persons for patrol in all sites of the whole line, and successfully completed power supply work for Boao Forum for Asia once again.




## 促进经济发展

#### The statistics in recent three years:

The corporate social contribution value of CREC in 2013 reached RMB 118.75 billion Yuan, and each share of social contribution value was RMB 5.58 Yuan.

The corporate social contribution value of CREC in 2014 reached RMB 130.51 billion Yuan, and each share of social contribution value was RMB 6.13 Yuan.

The corporate social contribution value of CREC in 2015 reached RMB 143.94 billion Yuan, and each share of social contribution value was RMB 6.3 Yuan.

#### 员工休假制度

## Maintenance of Staff's Rights and Interests

CREC paid high attention to maintenance of staff's rights and interests. and supported gender equality. Through the agreement and signature of labor contract according to law, it established a scientific system of salary management and maintained the staff's legal rights and interests.

#### Labor Contract Management

In 2015, the company strictly implemented the national Labor Contract Law, and the signature rate of labor contract in the whole company reached 100%. It earnestly implemented national laws and regulations on contract workers sent by corporates, actively adopted "four one-batch" measures ("clean up a batch, reform a batch, train a batch and transfer and enroll a batch"), strictly standardized management on contract workers sent by corporates, and actively maintained the migrant workers' legal rights and benefits.

#### Staff Salary Management

CREC built regular employee income increase mechanism and security mechanism and raised income of the employees gradually. In 2015, the company maintained staff income growth and corporate economic benefit growth, increased the income level of the staff in first line and in key position, and guaranteed the staff salary could be paid on time in full.

#### Staff Social Insurance Management

CREC protected legal social security rights and interests of the staff, supervised and urged member corporates to join in primary endowment insurance, basic medical insurance, work-related injury insurance, unemployment insurance and maternity insurance. In addition, the company actively implemented national requirements about industry and corporate social insurance to be listed into local management.

#### Democratic Rights of Staff

In 2015, the company held the 1<sup>st</sup> session of the second staff's congress. On the congress, the labor union signed CREC 2015 Collective Contract with the corporate on behalf of all staff; it insisted on the systems of staff's congress review of administrative work report, democratic appraisement to leaders, and staff proposal report, and further unblocked the channel for democratic participation, management and supervision.

#### Life Guarantee for Staff

In 2015, CREC formulated and issued Instructions to Staff Life Guarantee Work. The whole company further deepened the "three permissions and three preventions" commitments for staff care program and the activity of "warmth-delivery in two festivals" to help staff solve the difficulties. It totally inspected and reimbursed special fund over RMB 51.33 million Yuan for "three preventions" activity, and helped over 31,000 staff in difficulty. In addition, the company raised warmth-delivery fund of RMB 165 million Yuan and autumn study aid payment of RMB 7.23 million Yuan, and visited over 250,000 staff, retirees, first-line staff and peasant workers.

#### Staff Holiday System

The company strictly complied with the national labor legal regulations, carefully implemented the national Regulations of Paid Annual Leave of Employees and various other holiday regulations. It paid remuneration and overtime salary to staff that worked on legal holidays, public holiday or work overtime according to national legal regulations.

# 中国中铁大力实施"人才强企"战略,把人才资源视为企业的第一资源,努力做到人才资源优先开发、人才结构优先调整、人才投入优先保证、人才制度优先创新。

2015年,公司先后举办了2期领导干部井冈山党性教育 培训班、2期领导干部理论培训班、2期处级干部进修 班和2期三级施工企业总经理培训班,共培训领导干部 561人次。全公司共培训各级各类人才30余万人次,促 进了人才队伍能力素质的大幅度提高。

2015年,公司研究制定了《中国中铁2016-2020年高端 人才培养规划》,进一步完善了高端人才选拔培养机 制,有2人获"百千万人才工程国家级人选"和"国家 有突出贡献中青年专家"称号。修订完善了各系列高级 专业技术职务任职资格评审制度,进一步规范了专业技 术职务评审工作。全年共评审通过教授级高级工程师 168人、高级专业人才2600余人。全公司认定特级职业 项目经理3人,一级职业项目经理14人,二级职业项目 经理103人,三级职业项目经理208人,深入推进项目 经理职业化建设。

#### Promotion of Staff's Growth

CREC strongly implemented the "Talent Corporate" strategy, treated the talents as the first corporate recourse, made effort to give priority to development of talent resources, give priority to adjustment of talent structure, give priority to talent investment and give priority to innovation of the talent system.

In 2015, the company conducted party spirit education training twice in Jinggangshan for leading cadres, theoretical training twice for leading cadres, class for advanced studies twice for department leaders, and general manager training twice for Level 3 construction enterprise, with the total trained leading cadres of 561 person-time. The whole company has totally trained over 300,000 talents in all fields and promoted the substantially improvement of talent team in capacity and quality.

In 2015, the company studied and made 2016-2020 CREC High-End Talent Training Planning to further improve high-end talent election and training mechanism. ### Perfection of Management System

CREC is constantly taking "to maintain stable condition of safe production, to provide the society with safe and good-quality architectural products, to provide the public with pleasant environment and create safe and health working condition for the staff" as the most important aspect of its social responsibility. In the long-term construction production and project management process, CREC formed a complete set of perfect safety management system, including the safe production responsibility system, prevention of major accidents, safety input, safety education, safety management and safety inspection, safety assessment, rewards and punishments and so on.

CREC safety concept: hidden dangers in the fire, prevention is better than disaster relief, and responsibility is extremely heavy.

Safety management policies: safety first, prevention as the main and comprehensive management.

Safety management principles: unified leadership, responsibility, classification management and guidance, full participation.

Safety management objectives: building of intrinsic safe enterprise.

In 2015, CREC deeply carried out series of important spirits about safe production work issued by Central Party and the State Council, and further perfected regulations on safety and quality management. It insisted on "Red Line" awareness and intensified "Zero Accident" concept. The company studied and formulated Instructions for Safety and Risk Classification Management for Engineering Project (trial), Red Line for Safety Control of Crane Lifting Operation, Red Line for Explosion-Proof Control of Gas Tunnel Construction, Red Line for Safety Control of Confined Space Work, Key Points for Management and Control of Tunnel Measurement by Shield Method and so on. It defined hazardous operation risk links and management as well as key technical control points to be mandatory standard for corporate safety management. In addition, it further standardized construction and production behavior and effectively prevented and controlled safety and quality risk.

2015年,公司将九大类别项目安全风险从高到低分为四个等级,对特级风险项目的实施性施组和重点专项方案进行评审,全年完成评审17项,同时严格分级评审监督管理,推进分级负责制、层级现场稽查复核制、片区督导巡视覆盖制等,有效防控工程项目安全风险。

2015年,公司组织开展了系统性安全质量检查,覆盖 了216个建设及作业项目,对存在突出问题的受检单 位下发《专项督办通知书》,并监督到整改闭合。全 公司各施工企业共开展安全质量大检查、专项检查146 次,检查项目2103个,各单位稽查大队共稽查5629 个项目,有力促进了重点工程项目的安全质量管理工 作。

资料1:2015年,中铁七局深入推进项目自查、三级 公司排查、局稽查大队稽查、局区域包保领导督查的 "四位一体"安全监管模式,始终保持安全工作的高 压态势,全年没有发生安全责任事故,确保了全年安 全生产形势持续稳定、有序可控。

#### Implementation of Safeguard Measures

In 2015, the company classified the safety risk of 9 categories of project into four grades from high risk to low risk. It carried out evaluation to construction teams and key special schemes for special grade risk projects. So far, the company has completed 17 evaluations, and strictly performed grading evaluation supervision management to push forward grading responsibility system, hierarchy on-site audit review system and district supervision and patrol coverage system, etc. In this way, safety and quality risks in the project were effectively controlled.

In 2015, the company organized and carried out systematic safety and quality inspection, covering 216 construction and operation items. It issued Notice for Special supervision to those inspected units with prominent problems, and supervised them till to rectification closed. All construction units of the whole company totally carried out safety and quality inspection and special inspection for 146 times with 2103 inspection items. All audit teams performed audit 5629 items. All these works forcefully promoted safety and quality management work to key engineering projects.

Information 1: In 2015, CREC No.7 deeply pushed forward "Four-in-One" safety supervision mode of project self-inspection, three-grade company checking, inspection of bureau audit team and bureau regional competent leader supervision. It always kept tough stance on safety work, and there was no safety responsibility accident in the year, which ensured continuous stability and well-organization and controlling of safe production situations.

Information 2: In 2015, CREC No.3 deeply carried out series of activities such as making a vow of safe production before starting working, appointing mass safety supervisor and youth safety supervision post. It actively cultivated safety culture by taking "intrinsic safety" as the key point, and insisted on the policy of "promoting safety by science and technology" to increase the investment on safe production research and development and mechanization to improve safety level by science and technology.

#### 保障职业健康

> In 2015, CREC continued to adhere to the management concept of "people first and safe development", focused on "intrinsic safety and lasting stability", highlighted the staff's physical and mental health. It carried out staff safety education and training activities for engineering project in the whole company, and added "safe production and management module" on the headquarter's network office platform. The whole company carried out various safety educations and trainings as well as activities for 24200 times with 322326 person-time of staff who received education and assessment. In addition, the company cooperated with Capital University of Economics, Xianyang Cadre School and Shijiazhuang Party School to jointly conduct 7 training classes including registered safety engineer continuing education, assessment to "three categories of personnel" in highway and water transportation, and training to onsite construction management personnel. Totally about 850 safety and quality supervisors and construction technicians received the training. All construction enterprises under CREC accumulatively carried out construction technical training for 47308 times, of which, 26233 person-time were for leadership training, 411614 persontime were for management training, and 1031861 person-time were for operators (contract workers) training. These activities effectively improved technical quality and operation skill of the related employed persons, laying a solid foundation for safeguarding staff's occupational health.

> The whole company further perfected staff health record, regularly organized staff physical examination, conducted occupational injury insurance for the staff, carried out health lectures so as to lead staff and enterprises to control the occupational hazard source and actively carry out scientific prevention and treatment to occupational hazard by cooperating with related departments. On the construction

site, the company continued to increase fund investment, improve staff's working conditions, constantly improved the site dustproof, noise reduction and safety facilities, enhanced the inspection and treatment of all hazardous gas, dust, noise in the workshop, provided the personnel with working protection facilities and personal protecting materials that meet the safety and sanitation standards, maximally minimized the occupational hazards, and actively created the safe, clean, comfortable and harmonious working environment for the staff.

Information 1: CREC No.2 insisted on carrying out EAP staff help plan, and enhanced humanistic care and psychological counseling. On August 20, 2015, the New Project Department in Beijing from the 4<sup>th</sup> company of No.2 Bureau initiated the second mental health day by making "releasing pressure for beautiful life" as the theme to provide the grass-root staff with a platform to learn about psychological knowledge, deepen self-understanding and pay attention to mental health.

Information 2: According to the requirement of annual occupational health goal, CREC No.6 intensified management by a number of measures. It actively provided the personnel with working protection facilities and personal protecting materials that meet the safety and sanitation standards. The detection and treatment of all hazardous gas, dust, noise in the workshop was up to national and industrial health standard without any occupational disease case.



#### Improvement of Innovation System

According to the characteristics of construction industry and demand for self-development, the company took the upgraded project construction of technical innovation system as its opportunity to carry out overall planning and optimization and integration to existing scientific resources and set up "two grades and four layers" technical innovation system with Chinese characteristics with market as orientation, corporate as main body, project as carrier, national laboratory as basis, technical center as platform and professional R&D center as backbone through joint tackling and open scientific research so as to achieve technically innovative operation management mode with layers in longitudinal direction and divisions in transverse direction by taking CREC technical center as the leading, all member enterprises' technical centers as main body and all professional R&D centers as backbone, laying a solid foundation for scientific innovation.

In 2015, the company seriously implemented the central government's reform spirit in deepening innovation system, undertook the project of "Study of Innovation Mode of Central Construction Engineering Corporation" listed in the special work plan for SASAC central scientific innovation management. It became the only corporate in central construction corporates that undertook the special work plan project for central scientific innovation management. At present, the company has signed study project assignment book and engagement letter. It prepared study outline and investigation plan, and convened expert appraisal meeting on project initiation. Now, the study work is being carried out orderly. CREC made overall planning and highlighted innovation. Moreover, it has made stock company's "13<sup>th</sup> Five-Year Plan" for science and technology development to guide the company's scientific development and promote corporate structure adjustment and transformation and upgrading.

As the main participator and promoter of the development of Chinese and world architecture, CREC has not only been in pursuit of self-development for many years, but also taken the leading of industrial progress as its important responsibility, which mainly manifested in expanding the industrial scale, driving the industrial self-discipline, leading technical innovation, win-win cooperation with partners and so on.

As the first batch of national "innovative corporate" granted by Ministry of Science and Technology, SASAC and ACFTU (All China Federation of Trade Unions), the company owns 3 national laboratories, "national engineering laboratory for express railway construction technology" and "national key laboratory for shielding and tunneling technology" and "national key laboratory for bridge structure health and safety" as well as 7 postdoctoral centers. The company owns 11 nationally certificated technical centers and 36 provincially certificated technical centers, has successively set up 6 professional R&D centers for bridge, tunnel, electrification, advanced engineering materials and measurement technique, rail and construction equipments and 1 BIM technical application R&D center.



#### Strengthening Innovation Drive

In 2015, CREC carefully implemented the national guidance for scientific and technical works of "independent innovation, key spanning, supportable development and leading the future", carefully implemented the company's "12<sup>th</sup> Five-Year Plan" for science and technology development. It took powerful measures, improved corporate innovation system, speeded up the cultivation of corporate innovation team, intensified the corporate independent innovative capability, implemented corporate intellectual property strategy, achieved a number of internationally advanced and domestically leading scientific and technical results with independent intellectual property, and vigorously enhanced the corporate core competitiveness.

In 2015, the company implemented 1520 new scientific research projects listed in annual scientific development plan, of which, 217 ones were the projects under direct management of the stock company, including 22 major projects, 93 key projects, and 102 leading projects; there were 1303 projects were listed in stock company's scientific development plan and were managed by all units. ## Promotion of Energy Saving and Emission Reduction

The year 2015 was the final year of "12<sup>th</sup> Five-Year Plan" for energy saving and emission reduction, and the whole company actively carried out this work and successfully achieved all objectives in "12<sup>th</sup> Five-Year Plan" for energy saving and emission reduction.

There was no major illegal event on energy saving and emission reduction; and the pollutant discharge reached both relevant national and local discharge standards. In 2015, the comprehensive energy consumption per ten-thousand business income was 0.0610t standard coal, of which, the comprehensive energy consumption per ten-thousand business income was 0.0654t standard coal, which was reduced by 2.4% on year-on-year basis compared to the last year. During the period of "12<sup>th</sup> Five-Year Plan", the comprehensive energy consumption was reduced by 16.2% accumulatively, and the company successfully completed the bounded assessment index of energy saving and emission reduction in "12<sup>th</sup> Five-Year Plan" period.

CREC carried out overall national green construction demonstration project and standardized field construction for energy saving and emission reduction. In 2015, the company recommended 19 engineering projects to take part in the national green construction demonstration project, 2 of which won the "two-star GBDL certificate" issued by Ministry of Housing and Urban-Rural Development, and 48 engineering projects won the title of CREC standardized construction site for energy saving and emission reduction.

The company formulated Interim Measures for Evaluation and Promotion Management to Key Energy Saving and Low Carbon Technologies, which could guide all units to adopt advanced and suitable energy saving and low carbon technologies, processes and equipment to speed up energy saving and low carbon technology progress and popularity. In addition, it selected 8 technologies to be listed into CREC directory of key energy saving and low carbon technologies (first batch), and greatly promoted them for application in the company. Case 1: In the joint transportation project of Shenshuo Railway and Shuohuang Railway, CREC No.3 thoroughly analyzed the characteristics of huge energy consumption and long operation period, and performed effective transformation to the internal combustion engine. As a result, the transportation energy consumption was reduced greatly year by year.

Case 2: In Nanchang subway electrified equipment supporting project, CREC Electrification Bureau carefully studied the project construction characteristics, and performed overall transformation to tunnel water spraying vehicle. It developed a new type tunnel water spraying vehicle to increase washing efficiency and save water resource effectively.

Case 3: CREC-Xi'an Center Project met two-star GBDL requirement in the design of land saving and outdoor environment, energy saving and utilization, water saving and water resource utilization, material saving and material resource utilization, indoor environment quality and operation management, etc.

#### 加强环境治理

## Strengthening Environment Governance

On environment governance, CREC embodied the harmony of man and nature into every project, established the top-to-bottom and allaround monitoring green environmental protection management system and actively implemented the ecological environment protection work. Each project department of the company insisted on the principle of "construction of high-quality project, creation of civilized ecology", implemented company's high standard environmental protection and soil conservation measures and regarded "project guality and double excellence of environmental protection and water conservation " as its goal to strive to achieve the high degree of harmony and unity between highguality project and beautiful environment. For all investing construction projects, the company carried out environment influence evaluation as per local regulatory requirements, went through environmental approval procedures, and performed prepositive examination for environmental protection. The company strengthened monitoring to main pollute discharge points, and took effective measures in noise treatment, construction dust control, pollute discharge management, soil taking (discarding) site, abandoned residue transport and water body protection in order for compliance construction and green construction.

Information 1: CRSBG (China Railway Shanhaiguan Bridge Group Co., Ltd.) actively fulfilled social responsibility for green environmental protection. In 2015, it dismantled four units of 10 steam-ton coal-fired boiler and accessory equipment, and completed technical transformation to coal-fire boilers in original boiler room to perform reasonable and effective treatment to waste water, waste gas, solid waste and noise to greatly reduce pollute discharge.

Information 2: The Huaihua-Shaoyang-Hengyang Railway Project Department of CTG (China Railway Tunnel Group) attached high attention to environmental governance since it entered the construction site. It made great efforts in treatment of construction dust, tunnel slag, tunnel water and prevention of water and soil erosion. The Project Department allocated special water spraying vehicles to control dust on the village roads. In addition, it took the technical measures of slope masonry retaining wall and adopted permanent open channel discharge to all gullies. It planted grass at all side slopes of tunnel entrance, and all tunnel water was discharged through three-level sedimentation tank so as to really achieve "keeping green mountain unchanged with green water running forever". 37

## 保护生态环境

中国中铁始终致力于生态环境的保护工作,工程开工 前,均组织专业人士认真进行生态环境保护方面的评 估,制定切实有效的保护方案,特别是针对生态易受 扰的作业施工场区,开展水土保持、生物多样性保 护、植被保护等工作,做到生态环境与工程建设同步 规划,同步实施。施工过程中增加生态保护的投入, 使用环保设备、改进施工工艺和优化施工方案,减少 对水、大气、植被和生物的影响。全年未发生生态环 境事件。

公司积极参与国家重点环境保护实用技术和示范工程 的评审、推广工作,其中,山区道路建设耕地生态保 护技术、山区隧道施工弃渣"三化"处理技术、高速 铁路轨板厂生产污水回用技术等获得国家重点环境保 护实用技术。沪瑞国道(贵州境)镇胜高速公路高边 坡路堑生态防护工程段、合肥铁路枢纽北城制梁场节 水环保工程、天津市北塘污水处理厂工程等获得重点 环境保护实用技术示范工程。

资料1:2015年,中铁五局路桥公司在西成客专项目 建设了全国首个朱鹮防护措施试验段,对保护国家珍 稀动物朱鹮及列车的运营安全起到重要作用。

资料2:中铁大桥局参与建设的合福高铁铜陵长江大桥 跨越扬子鳄国家级自然保护区。在施工过程中,在每 一个钻孔桩钢护桶内安装泥浆泵,将泥浆提升至大桥 两端陆地临时工场处理,或用承接船运至岸边临时工 场沉淀,保证泥浆出渣一滴也不排入长江。为此,项 目部增加环保投入超过500万元,增加沉淀池、干化堆 积场36个,处理的泥浆近47万吨。

## Protection of Ecological Environment

CREC has always committed to the ecological environment protection. Before the project starting, CREC always organized professional personnel to evaluate the ecological environmental protection situations carefully, made practical and effective protection program, especially focusing on ecology in construction site that is liable to be disturbed, it developed works such as conservation of water and soil, biodiversity protection, vegetation protection etc. It planed and implemented the ecological environment management with the project construction synchronously. In the construction progress, CREC increased the investment in ecological protection, applied environmental protection equipment, improved ecological construction process and optimized construction program, thus reduced the impact on water, air, vegetation and organism. No ecological destruction event occurred throughout the year.

The company actively took part in the evaluation and promotion of national key practical technologies and demonstration projects of environmental protection, of which, such technologies as ecological protection technology for mountain road construction land, "3R" treatment technology for abandoned residue of tunnel construction in mountain area, and production wastewater recovery technology in high-speed rail board factory were rated as national key practical technologies for environmental protection. The projects such as high slope cutting ecological protection engineering section of Zhenning-Shengjingguan Expressway in Hurui national road (in Guizhou province), water saving and environmental protection project in north city fabricated beam plant of Hefei railway hub, and the project of Tianjin Beitang Sewage Treatment Plant were rated as key practical technology demonstration projects for environmental protection.

Information 1: In 2015, CREC No.5 Road and Bridge Engineering Company constructed the first national test section for crested ibis protection in Xicheng Railway Passenger Special Line project, playing an important role in protection of national rare animal crested ibis and train operation safety.

Information 2: CRBB (China Railway Bridge Bureau) took part in construction of Tongling Yangtze River Bridge of Hefei-Fuzhou high-speed rail which crosses over National Nature Reserve for Yangtze alligator. In the construction process, slurry pump is mounted in every steel protective barrel of drilled pile to be lifted up to the land temporary construction site at both ends of bridge for treatment, or to be shipped to the bank temporary construction site for sedimentation to ensure the slurry residues would not be discharged to Yangtze River. For this purpose, the project department increased the investment of over RMB 5 million Yuan in environmental protection, and increased 36 sedimentation tanks and drying dumps, which could treat nearly 470,000t of slurry.

多年来,中国中铁在一系列重大自然灾害面前挺身而 出,勇挑重担,积极投身抢险救灾;积极践行央企责 任,受到各级政府和社会各界好评。

2015年,全公司积极参与各地各类抢险救灾近300次, 投入抢险救灾人员近2万人次、设备3500多台套、投入 资金近5000万元。中国中铁目前有三支国家隧道专业 救援队,多次参与国家重大抢险救灾工作,成为国家 抢险救援的重要专业力量。其中,中铁二局昆明救援 队不断加强体系建设,编制完善了《隧道坍塌应急救 援作业指导手册》和《队员训练科目及考核标准》, 并受国家安全生产监管总局应急救援中心委托,编制 完成了《隧道坍方应急救援基地验收暂行办法》。 资料1:2015年12月20日深圳山体滑坡灾害发生后,中 国中铁所属中铁一局、二局、三局、隧道集团、港航 局、建设投资集团、中铁二院等多家单位积极行动, 立即组建救援队5支,投入抢险队员1000余人,大型机 械设备140多台套,以及木板、方木、帐篷、棉被、雨 具、矿泉水等大量救援物资,全力抢通东口和西口的 生命交通线,挖掘、清理、外运破损建筑混凝土、楼 板和滑坡土方数百万方。

资料2:2015年,天津港"8·12"爆炸事故发生后,中 国中铁所属中铁一局、五局、六局、七局、电化局、 建工集团等单位及时投入大量人力、物力,积极参与 救灾工作。出色完成了打通救援通道、整平和硬化地 面、抢救运送伤员、清运现场损毁汽车和集装箱、拆 除损毁建筑物等救援任务。







#### **Disaster Relief**

For many years, CREC has come out boldly and dared to challenge when facing series of serious natural disasters, and it actively took part in the rescue works; it actively fulfilled the responsibility of central enterprise, and has been highly praised by both the government and public.

In 2015, the whole company actively took part in various rescue and relief works in all places for nearly 300 times, with nearly 20,000 person-time of rescue and relief personnel, more than 3500 sets of equipment and nearly RMB 50 million Yuan of investment. At present, CREC has three national professional tunnel rescue teams, which have participated in national major rescue and relief work for many times, having become the important professional forces in national rescue work. Of which, Kunming rescue team of CREC No.2 constantly strengthened system building, and compiled and perfected Instruction Manual of Emergency Rescue Operation in Tunnel Collapse and Team Member Training Subjects and Assessment Standard. In addition, entrusted by Emergency Rescue Center of State Administration of Work Safety, it compiled Interim Measures on Acceptance of Emergency Rescue Base of Tunnel Collapse.

Information 1: On December 20, 2015, when landslide disaster in Shenzhen happened, CREC No.1, No.2, No.3, China Railway Tunnel Group, Port and Channel Engineering Group Co., Ltd., Construction Investment Group, China Railway Eryuan Engineering Group Co., Ltd and other units took active action. They immediately established 5 rescue teams and dispatched more than 1000 persons to join the rescue teams. Moreover, they had over 140 sets of large-scale mechanical equipment and large amounts of rescue materials including plank, lumps of wood, tent, quilt, rain gear and mineral water. They spared no effort for emergency rehabilitation of life line of east entrance and west entrance, and excavated, cleared and transported millions of cubic meters of damaged building concrete, floor slab and landslide earthwork.

Information 2: In 2015, when "8-12" explosion accident in Tianjin Port occurred, CREC No.1, No.5, No.7, China Railway Electrification Bureau, and Construction Engineering Group immediately invested large numbers of manpower and material resources to actively participate in rescue work. They successfully completed rescue tasks such as opening rescue channel, leveling and hardening ground surface, rescuing and carrying the wounded people, clearing damaged automobiles and containers on site and dismantling damaged buildings, etc.

2015年,根据国务院扶贫办有关安排,公司继续选派 3名副处级干部分别到湖南汝城、桂东和山西保德等三 个国家级贫困县挂职,全年一共投入 300万元用于改 善当地学习教育和生活条件,还从总部机关选派1名 优秀年轻干部到湖南汝城县朱家村挂职第一书记,协 助销售农产品5000余斤,申请到国家"母亲水窖"项 目,中国中铁拨付专项扶贫资金30万元,派出专业队 伍为该村进行饮水工程改造,捐赠了一批电脑、音响 等设备,改善当地学校和村民的学习文化生活。

资料1:2015年,公司针对保德具教育基础设施比较好 的实际情况,除了继续资助"中国中铁自强班"高中 学生完成学业外,把大部分资金用于支援袁家里养羊 项目,在产业扶贫方面迈出了新的步伐。此外,保德 县与中国中铁合作办学正式启动,第一批20名学生已 到中铁郑州技术学院学习,为下一步就业创造了新的 条件。

资料2:2015年,中铁五局选派两名干部分别进驻黔东 南丹寨县龙泉镇羊甲村和交圭村开展精准扶贫,积极 向地方主管部门争取扶贫资金近10万元,对两个村的 4800米饮水管网和灌溉水渠、1320米道路、120户电 路进行改造完善;先后4次参与所驻村贫困户、低保户 和五保户的评定与审核,动员260余人参加了农村养老 保险和房屋财产保险,指导村民开展稻田养鱼和泥鳅 84亩。

资料3:中铁科研院西北院与甘肃省榆中县韦营乡孙 家岔村结成帮扶对子,开展"精准扶贫"。先后选定 39名领导干部与贫困村民建立了"一对一"的帮扶关 系。投入32万元,扶持村民发展生态散养鸡项目,帮 助村民实现增收240万元。帮助村民提高"双垄沟" 地膜玉米、无公害马铃薯、胡麻等经济作物的种植能 力,帮助村民的农产品打开销路,扩大农民增收渠 道, 使孙家岔村成为首批脱贫村。

## Assistance for the Poor

In 2015, according to planning of Poverty Relief Office of the State Council. the company continued to select three cadres at deputy section level and dispatched them to take a temporary post in three national poverty counties, Rucheng and Guidong in Hunan Province, and Baode County in Shanxi Province. In the whole year, the company invested RMB 3 million Yuan accumulatively to improve local education and living conditions. In addition, it selected and dispatched one excellent young cadre to take a temporary post of Major Secretary in Zhujiacun Village of Rucheng, Hunan Province to assist sale of more than 2500kg of agricultural product, and applied for national ""Mother Reservoir" project. CREC made a payment of RMB300.000 Yuan for special poverty alleviation funds. It dispatched professional teams to the village for drinking water project transformation, and donated computers and audio devices to improve the conditions of local school and villagers' study and culture life.

Information 1: In 2015, aiming at good educational infrastructure in Baode County, in addition to continuously subsidizing high school students in "CREC Self-Strongness Class" to complete their studies, the company used the most of funds to support sheep breeding project in Yuanjiali Village, taking a new step in poverty alleviation through industralization. In addition, cooperative education between Baode County and CREC was officially launched, and the first batch of 20 students has come to CREC Zhengzhou Institute of Technology for study, which created new conditions for employment in the next step.

Information 2: In 2015, CREC No.5 selected and dispatched two cadres to respectively go to Yangjiacun Village and Jiaoguicun Village of Longguan Town of Danzhai County in the southeast of Guizhou Province for targeted poverty alleviation. They actively applied for nearly RMB100.000 Yuan of poverty alleviation funds from the local competent departments to transform and improve 4800 meters of drinking water pipe network and irrigation canal, 1320 meters of road and electrical network of 120 households; they took part in evaluation and examination of povertystricken family, low-income family and five guarantees family in the villages they stayed for four times, mobilized more than 260 people to join rural endowment insurance and house property insurance, and guided villagers to carry out rice fish and loach culture for 84 mu.

Information 3: The northwest branch of China Railway Science Research Institute was twinned with Sunjiacha Village of Weiying Town of Yuzhong County in Gansu Province for anti-poverty to carry out "targeted poverty alleviation". It has selected 39 leading cadres to set up "one-to-one" help relationship with poor villagers. Moreover, it invested RMB 320,000 Yuan to assist the villagers to develop ecological free-range chicken project to help them achieve increased income of RMB 2.4 million Yuan. In addition, it helped the villagers to improve cultivation capacity of industrial crops such as "double furrow" mulch corn and pollution-free potato and flax so as to help the villagers open up the market of agricultural products and expand the channels for farmers' income increase to make Sunjiacha Village become the first batch of anti-poverty village.

## 推进产业合作

2015年,公司积极推进在高速铁路、基础设施建设、 金融服务、建筑材料等领域的产业合作。在高速铁路 建设领域,公司充分发挥中国高速铁路发展领军企业 的优势,与中国铁路总公司等国内企业合作,共同推 进"中国高铁走出去",带领中国铁路产业铸就"中 国高铁"的金色品牌。在基建领域,与湖北省交通投 资集团、北京金隅集团、碧桂园集团等大型企业开展 战略合作,积极参与国内基础设施投资建设。在金融 服务领域,与中国银行、中国建设银行、光大证券等 金融机构积极开展合作,创新投融资模式,建立完整 的业务链条。在供应商合作方面,与中石油、河北钢 铁、陕西钢铁、京东等企业展开战略合作,不断加强 集中采购管理,降低采购成本。

资料1:2015年,中国中铁通过与中石油的战略合作,将系统内石化产品的需求优势与中石油的资源优势有机结合,在596个项目实现石化产品集采专供,完成供应37.6万吨,降低成本约1.5亿元。

资料2:2015年5月,公司与京东达成办公用品战略 合作协议,京东入驻中国中铁采购电子商务平台鲁班 商城,以专属优惠价格向公司提供各类办公用品,实 现了办公用品在线集中采购管理,全年完成新签订单 4152个。

#### Promotion of Industrial Cooperation

In 2015, the company actively pushed forward industrial cooperations in high-speed rail, infrastructure construction, financial service and building materials. In high-speed rail construction field, the company gave full play to its advantage of being a leading corporate in China high-speed rail development, cooperated with China Railway Corporation and other domestic corporates to jointly promote "China high-speed rail going out", and led China railway industry build up a golden brand of "China High-Speed Rail". In infrastructure construction filed, the company carried out strategic cooperation with large-scale corporates such as Hubei Communications Investment Group, Beijing Building Materials Group and Country Garden Holdings to actively take part in domestic infrastructure investment and construction. In financial service field, the company actively carried out cooperations with Bank of China, China Construction Bank and Everbright Securities to innovate investment and financing mode and set up complete business chains. In supplier cooperation, the company carried out strategic cooperations with China National Petroleum Corporation, Hebei Iron and Steel, Shaanxi Iron and Steel and JD.com to constantly intensify the centralized procurement management and reduce procurement cost.

Information 1: In 2015, through the strategic cooperation with China National Petroleum Corporation, CREC effectively combined the advantages of demand for petrochemical products in the system with the resource advantage of China National Petroleum Corporation to achieve centralized procurement and supply of petrochemical products in 596 projects. It supplied 376,000 tons of petrochemical products and reduced cost of about RMB 150 million Yuan.

Information 2: In May 2015, the company reached strategic cooperation agreement with JD.com on office supplies. JD.com entered Luban.com on CREC procurement e-business platform to supply the company with various office supplies in specially preferential price and achieved on-line centralized procurement management to office supplies. It completed 4152 newly-signed orders in the year.

This project became the first contract project of CREC for "going out".

## **Global Development**

In 2015, CREC achieved overseas business income of RMB 30.15 billion Yuan.

In 2015, the company carried out abroad engineering project design, construction and product processing and export businesses in 68 global countries and areas. At present, it has 405 abroad engineering projects under construction, involving railway, highway, bridge, tunnel, housing construction, urban rail, municipal project, farmland and irrigation and water conservancy as well as port construction; its projects were distributed in South America, Eastern Europe, Africa, South Pacific, Southeast Asia, and Middle East; its processed products of high manganese steel rail turnout and steel structure were sold to 19 countries and areas including the U.S, South Korea, Danmark, New Zealand, Hong Kong, Mozambique, Bangladesh, Australia, Vietnam, Indonesia, Thailand, Ethiopia, Nigeria, Malaysia, Sierra Leone, India, Tanzania, Turkey and Laos, etc.

In addition, the company invested and established Mali Textile Mills and Cote d'Ivoire Pharmaceutical Company in the outside, and carried out real estate development in South Africa, Tanzania and Papua New Guinea. It conducted infrastructure project based on mineral resources exchanges in Congo-Kinshasa and other African areas.

For a long time, CREC insisted on the idea of "offering high-quality project and benefiting host country", and carried out more than 200 large overseas engineering projects represented by major international engineering projects including UAE Palm Island reclamation project, Bangladesh Paksey Bridge project, Malaysia SABAH railway transformation project, Nigeria railway reconstruction project, South African dam project, assisted Ghana highway reconstruction and extension project, Angola Luanda Province hospital project and Morocco expressway, and Malaysia Kuala Lumpur MRT, Ethiopia Addis Ababa-Djibouti railway under the construction. All these projects showed high attention of CREC to social responsibility to the countries of its overseas engineering projects. In 2015, during the implementation of overseas contract projects, CREC not only contributed a number of high-quality projects and beneficial projects but also improved the local transportation capacity, improved the public living conditions, speeded up economic and trade exchanges between the host country and surrounding countries, promoted the local economic prosperity and development, and actively offered employment opportunities for the local people. In the full year, the company employed 44,000 local workers for its overseas projects.

Information 1: In 2015, CREC gained important breakthrough for a batch of major overseas projects including China-Russian high-speed rail, China-Lao railway, China-Thailand railway, Indonesia high-speed rail, American western fast line, South America Pacific-Atlantic Railway, etc.

Information 2: On September 20, 2015, Addis Ababa light rail project in the capital of Ethiopia undertaken by CREC, designed and constructed in accordance with Chinese technical standards by using Chinese equipment and operated and managed by Chinese joint venture was officially put into operation, and CREC will continue to provide operation and maintenance management services for Ethiopia party.

Information 3: Indonesia Jakarta-Bandung high-speed rail participated by CREC was adopted with Chinese technical standards and equipment, and it was the first contract project of Chinese high-speed rail "going out" from technical standard, survey and design, project construction, equipment manufacturing, material supply to operation management, talent training and comprehensive development along the line.

#### **Global Public Welfare**

For a long time, CREC has always actively participated in international public welfare undertakings, and provided material assistance to improve the people's living standard in the host country of its engineering project by means of donation, contribution, and donations to schools; by constructing roads, bridges and other infrastructure and beneficial engineering projects such as residents' drinking water and sewage disposal free of charge, it helped the host country to solve a lot of major livelihood issues; through promotion of localized management of its overseas engineering projects, it enhanced local talent cultivation, and cultivated a large number of technical talents which greatly promoted the development of local social economy.

Information 1: Since the establishment of CREC No.4 Angola construction site hospital, it provided the local Chinese with medical service, provided the local residents with free meals and medical care services, popularized the disease prevention knowledge for the local residents, actively carried out gratuitous treatment and participated in the local major epidemic treatment. Through all these public welfare activities, CREC not only completed health care work for more than 4000 employees in the construction site of Angola engineering project, but also undertook the medical treatment task for Angola's Chinese and the local residents. Under the conditions of extreme shortage in overseas medical devices and medicines, it carried out a series of difficult and high-risk operations to successfully rescue over 600 cases of seriously ill patients suffering from shooting injury, hemorrhagic shock, cerebral malaria and gastric perforation, etc. In addition, it also successfully treated and cured over 4000 cases of dengue fever patients, and over 2000 cases of falciparum malaria patients. CREC No.4 construction site hospital has become the largest Chinese hospital in Angola, setting up a bridge for China-Angola friendship.

Information 2: In 2015, FMO Project Department of CREC No.10 Venezuela Branch offered large numbers of employment opportunities. It employed 370 Venezuela workers, and invested RMB 700,000 Yuan for the construction of life, culture and sanitation on construction site, RMB 900,000 Yuan for environmental protection, RMB 300,000 Yuan for local education institutions; it organized 2 volunteer service teams and carried out service for 4 times; it conducted anti-poverty for Venezuela employees for 20 person-time with the investment of RMB 80,000 Yuan; it participated local rescue and relief for 4 times with rescue personnel of more than 90 persontime, 30 sets of equipment and investment fund of RMB 800,000 Yuan, gaining good reputation among the local residents.

Information 3: In 2015, Sino-Congo Mines Co. Ltd of China Railway Resources Group Co., Ltd published Five-Year Plan for "Harmonious Community" Construction in Congo-Kinshasa mines, trying to create a harmonious community of "benefiting Congo and the people's livelihood". It invested nearly USD 80,000 for construction of transformer substation and power supply supporting facilities to benefit 25,000 local people; it invested USD 1 million to repair Dusay Deanna School campus and upgraded farm product fair, football field and basketball field. It regularly conducted donations to school and gratuitous treatment, and donated sports goods to St. Maria Primary School and Dusay Deanna Middle School with 200 schoolbags, 50 sets of football suit, 20 footballs, 200 pieces of skipping ropes which were valued at USD 5000 totally; it organized 6 medical staff to carried out physical examination for more than 100 teachers and students free of charge, and granted 10 kinds of treatment and preventive drugs of over 200 boxes totally.

#### Normative Information Disclosure

As a listed A+H company, in 2015, the company actively studied new changes of China capital market reform, and constantly adapted to the new requirement for information disclosure supervision model of Shanghai and Hong Kong. It actively implemented industry-classified supervision and "through train" business requirement, continuously intensified efforts on internal major events report, and strictly performed the obligation of information disclosure. In 2015, the company released 288 notices and circulars which reached a new high in quantity of notice document, including 122 A-Share notices and 166 H-Share notices and circulars, with the contents covering conference resolutions, regular reports, related transaction, payment of interest of bonds, equity financing, signing of strategic cooperation agreement, domestic and abroad major project bidding and other major issues that should be disclosed; in the meantime, focusing on the concerns of market and supervision institutions, the company initiatively enhanced voluntary information disclosure force, especially intensified information collection and disclosure of bidding winning information for major projects and information on "One-Belt and One-Road" business operation. There was no false record, misleading statement or big misstatement in the full year. Its information disclosure work in 2014 was rated as A by Shanghai Stock Exchange (SSE), i.e. excellent information disclosure. In addition, it was awarded "Sunshine Prize for Information Disclosure of China Securities Market". The company notices and circulars were released on websites of SSE and SEHK and their designated newspapers and periodicals according to relevant regulations. Moreover, in order to make it easier for investors to check the information, information disclosure documents were also released on Chinese and English websites of the company. As a result, shareholders and investors can get information of the company in time and conveniently.
